Description of the service	<p>ELIXIR AAI is the common gateway to the services the ELIXIR research infrastructure provides for biological data.</p> <p>ELIXIR AAI (Authentication and Authorization Infrastructure) carries out the authentication of an ELIXIR user and manages and delivers their access rights and other relevant personal data to the ELIXIR services relying on it.</p>

Personal data processed	<p>ELIXIR AAI gathers following personal data from you</p> <ul style="list-style-type: none">- your name- your email address- your membership in the groups you are affiliated to within ELIXIR- your external identifiers provided by your identity provider <p>If you register using your identity provider (can be your home organization, Google, LinkedIn, ...) user account, the following data is retrieved:</p> <ul style="list-style-type: none">- your unique user identifier- your name- name of your Home organisation- your role in your home organisation (if applicable); if you are a faculty member, staff, student, etc.- optionally, your email address
Purpose of the processing of personal data	<p>ELIXIR AAI processes your personal data to identify and authenticate you as a user of the ELIXIR services, and to manage your access rights and other personal data for the ELIXIR services.</p> <p>The log files produced by the AAI components will be used only for administrative, operational, accounting, monitoring and security purposes.</p>

Third parties to whom personal data is disclosed

As a gateway to ELIXIR services, ELIXIR AAI will release your personal data to the ELIXIR services you are using. Data release will be done according to the sections 2.f and 2.l of the Data Protection Code of Conduct¹. You agree that the logged information may be disclosed to other authorised participants via secured mechanisms, only for the same purposes and only as far as necessary to provide the services.

Data retention

Your personal data is deleted on request or if you have not logged in to ELIXIR AAI for 24 months. The operational logs and related information is kept independently in order to guarantee the security of the infrastructure and its optimization.

Your personal data will be protected according to the Code of Conduct for Service Providers¹, a common standard for the research and higher education sector to protect your privacy.
